Subject: Consultation on the closure of Willington Lower School at the end of 2016/17 academic year

1. <u>Executive Summary</u>

This report is requesting Portfolio holder decision on whether to issue a consultation to the public on the closure of Willington Lower School

2. Recommendations

- 2.1 The Portfolio Holder is requested to consider the report and, if satisfied, approve the publishing of a consultation on the closure of Willington Lower School and the expansion of Cople Lower School for no less than 6 term time weeks from 14 Oct 2016 running until 5 December 2016.
- 2.2 The Portfolio Holder is requested to consider the consultation after 5th December and, if satisfied to continue the process, approve the publishing of statutory closure notice for Willington Lower School and expansion of Cople Lower School for 4 weeks from 7 December 2016 until 4 January 2017.

3. Reasons for Recommendations

3.1 To enable the merging of Willington Lower School and Cople Lower School into one Primary School across the two school sites.

4. Key Implications

4.1 <u>Legal Issues</u>

The process for school closure found in the Department for Education Statutory guidance for proposers and decision-makers (April 2016).

Policy Issues

4.2 The Executive agreed policy of two tier education in Bedford Borough on 20 January 2016.

Resource Implications

- 4.3 Full Council approved the capital budget for two tier conversion works on 3rd February 2016.
- 4.4 The continuing Primary School will operate on both school sites to ensure all current resources continue to be utilised.

Risk Implications

4.4 The risk of this not being approved is that Willington Lower School would continue within a two tier school system.

Environmental Implications

4.7 There are no environmental impacts.

Equalities Impact

- 4.8 In preparing this report, due consideration has been given to the Borough Council's statutory Equality Duty to eliminate unlawful discrimination, advance equality of opportunity and foster good relations, as set out in Section 149(1) of the Equality Act 2010.
- 4.9 The equality analysis is being conducted throughout the statutory process and will be finalised and acted upon towards the end of the process.

5. <u>Details</u>

- 5.1 There has been excellent joint working between Cople Lower School and Willington Lower School.
- 5.2 In the emerging two tier system the proposal is that one school exists across the current Cople Lower School and Willington Lower School with one school registration number.
- 5.3 To achieve one school with one school registration number across the two sites once school must close. For the avoidance of doubt there is no intention to close wither of the school sites. This is about merging both sites into one school.
- 5.4 The proposed consultation period is outlined below;

7 th October 2016	Portfolio Holder decision to consult on the closure of Beauchamp Middle School and, after reviewing the consultation, to publish statutory proposals if necessary.
14 th October 2016	Consultation starts
5 th December 2016	Consultation ends
By 7 th Dec	Portfolio holder to review consultation and decide whether to publish statutory proposal to close school and extend age range of school remaining open.
^{7th} Dec	Publish statutory proposal with a 4 week representation period
4 th Jan	4 week representation period ends
By 18 th Jan	Portfolio Holder decision (post consultation and statutory notice period) to consider whether to submit paperwork to School Adjudicator on school closure.

This decision enables the portfolio holder to review the consultation during august and make a decision on whether to continue the process by issuing the statutory notices. The submission of the proposal to the school adjudicator would be subject to an additional decision.
