

## **Report by - Chief Officer for Environment**

### SUBJECT - To approve a contribution of £500 to Bedfordshire Against Covanta Incinerator Group.

### 1 <u>Executive Summary</u>

To approve a contribution of £500 to Bedfordshire Against Covanta Incinerator Group in order to support a judicial review commenced by BACI Bedfordshire Ltd to challenge the decision to award an Environmental Permit under the Environmental Permitting Regulations (EPR) in respect of a proposed Resource Recovery Facility close to the village of Stewartby.

### 2 <u>Recommendations</u>

That the Mayor considers, and if satisfied, agrees to:

### Approve a contribution of £500 to Bedfordshire Against Covanta Incinerator Group

#### 3 Reasons for Recommendations

To contribute to the proceedings of the judicial review challenge in view of the anticipated adverse impact the proposed Resource Recovery Facility will have on that area of the Borough.

### 4 Key Implications

(a) <u>Policy</u>

#### Corporate Plan: - (themes taken from the 2017-21 Corporate Plan)

The Council's Corporate Plan 2017-2021, Bedford Borough – the place to grow, focuses on four goals to get the best for the people of Bedford Borough. This funding meets two of these goals. 'Enhance Places' – enhancing the local areas we are responsible for, and encouraging positive activities; and 'Empower Communities' – individuals, communities and associations coming together.

(b) Legal Issues

External legal advice has been sought in relation to the risk to the Council of a third party cost order being made. The risk of such an order is reduced where a crowd funding scheme supports the litigation and in particular where any contribution from a third party is not substantial in relation to the total costs of the sum of the crowdfunding.

### (c) <u>Resource Implications</u>

There are no conditions or future costs associated with providing this contribution and funding can be met from existing budgets.

### (d) <u>Risk Implications</u>

As identified in the legal section above in relation to third party cost orders.

To not make the contribution sum available could have detrimental implications for the proceedings identified.

#### (e) Environmental Implications

By contributing to these proceedings it is perceived this will have a positive impact on the environment should the judicial review challenge be successful it will improve the air quality in that area of the Borough.

#### (f) Equalities Impact

In preparing this report, due consideration has been given to the Borough Council's statutory Equality Duty to eliminate unlawful discrimination, advance equality of opportunity and foster good relations, as set out in Section 149(1) of the Equality Act 2010.

There are no equality and diversity implications in connection with the proposals that are set out in this report, and no differential impacts are reasonably foreseeable.

#### 5 Details

Following a protracted process featuring significant engagement by local groups and residents and opposition by Central Bedfordshire Council and Bedford Borough Council, Covanta was given consent following the granting of a Development Consent Order (DCO) originally on 13 October 2011, by a Panel of Commissioners appointed by the Infrastructure Planning Commission (IPC) to build an Resource Recovery Facility at the Rookery Pit South site that would burn 585,000 tonnes of waste a year generating 65MW of energy.

Although Covanta has been granted consent to build the Resource Recovery Facility and associated buildings in order to operate the buildings as an facility Covanta was required to apply for an Environmental Permit, it is this process and the Environment Agency which is being challenged in court on 10 and 11 October 2018. This funding will support the Bedfordshire Against Covanta Incinerator Group in relations to the costs of this judicial review challenge.

Bedfordshire Against Covanta Incinerator (BACI) is a campaign group which describes itself as a 'coalition of Residents, Parish & Borough Councillors and Action Group Members opposed to the Covanta's Resource Recovery Facility.' The group has launched a 'crowdfunding' appeal for donations to fund the costs of the Judicial Review proceedings it is taking against the decision to award an environmental permit for the operation of the proposed Resource Recovery Facility at Rookery South Pit. The group is seeking donations from a broad base of donors in order to meet its fundraising target of £51,500. As of 9th October, its fundraising total had reached £50,300.

Bedford Borough Council and Central Bedfordshire Council have also opposed the award of the environmental permit via their submission to the Environment Agency.
