  - (1) organisations should identify any criteria or skills requirements, although the Mayor will not be bound by this; and
  - (2) Where the work of an outside body relates in whole or in part to a particular geographic area or Ward(s) then, when the Ward Member(s) for that area has expressed a willingness to serve and has the relevant experience, the Mayor will give priority consideration to those Member(s).
- 5.7 The need for representation on Outside Bodies generally, is reviewed every 4 years prior to Borough Council elections taking place. Where a Council representative is no longer required, the organisation is removed from the list of appointments.
- The Mayor is invited to make appointments to the bodies listed in accordance with the nominations received from Group Leaders and to consider the appointments to the bodies where more nominations than places have been received.
