 - The Dog Exclusion Order;
 - ii) The Fouling of Land by Dog Order;
 - iii) The Dogs on Leads Order;
 - iv) The Dogs on Lead by Direction Order.
- (2) That the Deputy Chief Executive & Executive Director for Environment, following consultation with the relevant Portfolio Holder, be authorised to review the Public Spaces Protection Order at Appendix C, its implementation, development and scope during the period covered by the Order, with any proposed variations/discharge to be approved by the Executive.

2. Date of decision

14 July 2025

3. Reasons for decision

Public Spaces Protection Orders (PSPOs) are designed to ensure the law-abiding majority can use and enjoy public spaces, safe from anti-social behaviour. The prohibitions included in the PSPO for Dog Control is proportionate, based on evidence, consultation responses and analysis and are necessary to address the ongoing issues within the specified designated locations.

The Council remains satisfied that activities such as dog fouling will continue to have a detrimental effect on the quality of life of those in the locality and those activities will be persistent or continuing in nature as such to justify the restrictions to be imposed in the PSPO.

The Council regularly receives complaints about dog fouling and dogs in areas where they are excluded or must be on a lead. It is important that the council responds to these concerns to ensure that the law-abiding majority can use and enjoy clean public spaces, safe from anti-social behaviour.

The new locations to be added to the PSPO were requested by the relevant Parish Councils as part of the consultation process.

The extension of the PSPO for dog control and the adoption of the restrictions in the new locations will allow the Council to continue to take enforcement action for this anti-social behaviour, and by adopting the new locations will also ensure a consistent enforcement approach is taken for similar types of amenity land across the borough.

The existence and enforcement of dog control PSPO's has helped the Council to address the issues that gave rise to the original order but it is clear that members of the public continue to carry out the anti-social activities that the order seek to prevent and will inevitably increase if the extension of the PSPO is not approved.

4. Alternatives considered and rejected

To not extend the PSPO – this is rejected as there remains a need to prohibit these behaviours and have an appropriate enforcement tool to take action against those that commit this anti-social behaviour.

<u>To extend the PSPO but not add the additional new locations</u> – this is rejected as the new locations meet the same criteria as other locations in the Borough that have the same type of dog control restrictions.

5. How decision is to be funded

Any financial implications of the recommendation for a new PSPO for a three-year period will be funded from within existing resources as part of the Regulation, Housing & Customer Contact Service Group.

1. **EXECUTIVE SUMMARY**

1.1. This report provides a summary of the proposal to extend the existing Public Spaces Protection Order (PSPO) for Dog Control Orders for an additional three years with the addition of new locations as identified through consultation.

2. **RECOMMENDATIONS**

- 2.1. The Mayor is asked to consider and, if satisfied, to:
 - a) Approve the extension of the Public Space Protection Order for Dog Control across the borough for a further three-year period, along with the adoption and implementation of the <u>new</u> sites in accordance with Statutory Powers and Processes with effect from 27 July 2025 which will cover:
 - i) The Dog Exclusion Order
 - ii) The Fouling of Land by Dog Order
 - iii) The Dogs on Leads Order
 - iv) The Dogs on Lead by Direction Order
 - b) Agree that the Deputy Chief Executive & Executive Director for Environment, following consultation with the relevant Portfolio Holder, be authorised to review the Public Spaces Protection Order at Appendix C, its implementation, development and scope during the period covered by the Order, with any proposed variations/discharge to be approved by the Executive.

3. REASONS FOR RECOMMENDATIONS

- 3.1 PSPOs are designed to ensure the law-abiding majority can use and enjoy public spaces, safe from anti-social behaviour. The prohibitions included in the PSPO for Dog Control is proportionate, based on evidence, consultation responses and analysis and are necessary to address the ongoing issues within the specified designated locations.
- 3.2 The Council remains satisfied that activities such as dog fouling will continue to have a detrimental effect on the quality of life of those in the locality and those activities will be persistent or continuing in nature as such to justify the restrictions to be imposed in the PSPO.
- 3.3 The Council regularly receives complaints about dog fouling and dogs in areas where they are excluded or must be on a lead. It is important that the council responds to these concerns to ensure that the law-abiding majority can use and enjoy clean public spaces, safe from anti-social behaviour.
- 3.4 The new locations to be added to the PSPO were requested by the relevant Parish Councils as part of the consultation process.
- 3.5 The extension of the PSPO for dog control and the adoption of the restrictions in the new locations will allow the Council to continue to take enforcement action for this anti-social behaviour, and by adopting the new locations will also ensure a consistent enforcement approach is taken for similar types of amenity land across the borough.
- 3.6 The existence and enforcement of dog control PSPO's has helped the Council to address the issues that gave rise to the original order but it is clear that members of the public continue to carry out the anti-social activities that the order seek to prevent and will inevitably increase if the extension of the PSPO is not approved.

4. THE CURRENT POSITION

- 4.1 The Council first introduced a PSPO for dog control in July 2016 and this order was extended in 2019 and again 2022 for a further three years ending on 26 July 2025. The current PSPO has four elements:
 - The Dogs on Leads by Direction Order
 - The Fouling of Land by Dogs Order
 - The Dogs Exclusion Order
 - The Dogs on Leads Order
- 4.2 The enforcement of the current PSPO is primarily undertaken by the Council's Enviro Crime team, including an enforcement contractor of uniformed patrolling officers. This contract provision compliments the enforcement work of the Council and is cost neutral to base budgeting.

4.3 Currently there are over 150 areas within the Borough that have either a 'dog excluded' or 'dog on lead' restriction under the PSPO.

5. <u>DETAILS</u>

5.1 The PSPO for dog control has four elements:

• The Dogs Exclusion Order

The effect of the Order is to make it an offence for a person in charge of a dog to permit the dog to enter or remain on any land to which this Order applies.

The Dogs on Leads Order:

The effect of the Order is to make it an offence for a person in charge of a dog to fail to ensure that a dog is kept on a lead on any land to which the Order applies.

The Dogs on Leads by Direction Order:

The effect of the Order is to make it an offence for a person in charge of a dog to fail to put that dog on a lead under the direction of an authorised officer on any land to which the Order applies.

- The Fouling of Land by Dogs Order:
- The effect of this Order is to make it an offence for a person in charge of a dog to fail to remove faeces forthwith from any land to which the Order applies.
- 5.2 The PSPO for 'dog fouling' and 'dog on lead' by direction covers <u>any place in the Borough</u> to which the public or any section of the public has access, on payment or otherwise, as of right or by virtue of express or implied permission.
- 5.3 The areas where a 'dog is excluded' are <u>primarily play areas and enclosed sports pitches</u>, areas where a 'dog must be on a lead' are <u>Bedford town centre</u> plus other <u>open spaces/parks</u> that have mixed use areas that include more <u>open sports pitches</u> and <u>some churches and graveyards</u>.
- 5.4 Enforcement of a PSPO is either by way of a Fixed Penalty Notice (FPN) or Prosecution via the magistrates Court, a FPN is issued as an alternative to prosecution and if paid a person discharges their liability for that offence.
- 5.5 Since June 2019 the Council has received 968 dog fouling complaints and 90 FPNs have been issued for dog control offences.
- 5.6 When consideration is given to extend the PSPO for dog control it is necessary to consider if new locations need to be added to the order, often this will be as a result of new housing developments or because locations have experienced the detrimental effects of irresponsible dog owners since the original order was introduced.

5.7 In December 2024 all of the Borough's Parish Councils were contacted to request details of any new locations to be considered for adding to the PSPO. The new requests were reviewed to determine if they were appropriate, in line with restrictions elsewhere within the Borough and if they were enforceable. The locations requested that meet these criteria are detailed below:

- 5.8 Section 60 of the Anti-Social Behaviour, Crime and Policing Act 2014 allows a local authority to extend an existing order providing the extension is necessary in order to prevent:
 - occurrence or recurrence of activities identified in the order from taking place after the expiry of the existing order, or
 - the frequency or seriousness of those activities increasing after the expiry of the existing order.
- The evidence available to the Council demonstrates that there is such a need. When the Council previously introduced the order for dog control, the Council was satisfied on reasonable grounds that the activities that were being carried out or likely to be carried out in the identified public space:
 - has had, or is likely to have, a detrimental effect on the quality of life of those in the locality
 - is, or is likely to be, persistent or continuing in nature
 - is, or is likely to be, unreasonable and
 - justifies the restrictions

5.10 It is likely that such activities will continue and will inevitably increase if the PSPO is not in place. In the circumstances, there is justification to extend the existing order and incorporate the new locations requested.

6. ALTERNATIVES CONSIDERED AND REJECTED

- 6.1 <u>To not extend the PSPO</u> this is rejected as there remains a need to prohibit these behaviours and have an appropriate enforcement tool to take action against those that commit this anti-social behaviour.
- 6.2 <u>To extend the PSPO but not add the additional new locations</u> this is rejected as the new locations meet the same criteria as other locations in the Borough that have the same type of dog control restrictions.

7. KEY IMPLICATIONS

Legal Issues

- 7.1 The Anti-Social Behaviour, Crime and Policing Act 2014 was enacted on 20 October 2014. The Act introduced changes to how local authorities can deal with anti-social behaviour (ASB) and are designed to put victims first and give greater transparency and accountability.
- 7.2 The Act introduced PSPOs as a replacement to Designated Public Place Orders (DPPO), Gating Orders and Dog Control Orders. PSPOs are intended to deal with a particular nuisance or problem in a particular area which is detrimental to the local community's quality of life, the Order imposes conditions on the use of that area which apply to all who use it. PSPOs are designed to ensure the law-abiding majority can use and enjoy public spaces, safe from anti-social behaviour.
- 7.3 On receiving approval of the Order(s) from the Executive, the draft Order(s) will be published in accordance with regulations published by the Secretary of State, these being:
 - Publish the Public Spaces Protection Order(s) as made, on the Bedford Borough Council website
- 7.4 The final set of restrictions that forms the Order(s) will then be published in accordance with regulations made by the Secretary of State (published on the Bedford Borough Council website, together with the erection of signage sufficient to draw the public's attention to Order(s) and its effect) and will:
 - Identify the activities having the detrimental effect
 - Explain the potential sanctions available on breach
 - Specify the period for which the PSPO has effect

7.5 The PSPO will remain in place for three years from the date of commencement and there is flexibility to review and vary the terms of the Order(s) during that time if a new issue arises in the area where the Order(s) are in force. As well as varying the PSPO, the Council can also seek to discharge it at any time.

Policy Issues

- 7.6 The Bedford Borough Corporate Plan 2024/5 2027/8 focuses on four strategic priorities of:
 - Supporting Individuals and Families
 - Protecting the Environment
 - Simulating Economic Growth in Bedford Borough
 - Promoting Health and Wellbeing
- 7.7 The PSPO is relevant to all goals, but particularly 'Protecting the Environment' to deliver cleaner, greener and safer places.

Resource Issues

7.8 Any financial implications of the recommendation for a new PSPO for a three-year period will be funded from within existing resources as part of the Regulation, Housing & Customer Contact Service Group.

Risks

- 7.9 Whilst the vast majority of the dog owners are responsible with their dogs, a small minority are not. Dog fouling and nuisance behaviour of dogs are regularly identified as one of the top concerns and risks of residents. Residents are concerned about dog fouling in particular and are worried about the amount of dog fouling, not just because of the mess it causes, but because it can also be linked to health risks, especially with children who play in the parks and open spaces.
- 7.10 These orders make it easier to deal with this type of anti-social behaviour, while at the same time encouraging responsible behaviour, thus reducing the risks as identified above.

Environmental Implications

7.11 There are no negative environmental impacts associated with recommendations in this report. Actions to reduce behaviours associated with irresponsible dog ownership will have a positive impact on our parks and open spaces.

Equalities Impact

7.12 In preparing this report, due consideration has been given to the Council's statutory Equality Duty to eliminate unlawful discrimination, advance equality of opportunity and foster good relations, as set out in Section 149(1) of the Equality Act 2010. Separate Equalities Impact Assessments are detailed in **Appendix D**.

Impact on Families

7.13 Taking measures to reduce anti-social behaviour associated with irresponsible dog ownership will contribute to ensuring that children, young people and families are able to enjoy public spaces and the benefits that brings in terms of wellbeing and reducing isolation.

Community Safety and Resilience


7.14 The PSPO looks to address issues that impact on residents' ability to enjoy our parks and open spaces. It will contribute to the Bedford Borough Community Safety Partnership aims of tackling anti-social behaviour and increasing public confidence in the delivery of community safety.

Impact on Health and Wellbeing

7.15 The restrictions that prohibit behaviours regarding irresponsible dog ownership in our parks and open spaces will contribute to the residents of the Borough being able to enjoy those spaces which bring benefits in terms of their overall health and wellbeing and physical activity.

- 8.3 A public consultation exercise was carried out by Bedford Borough Council between 8 April and 27 April 2025 via the Council website with copies made available in the Council Libraries.
- The following organisations were contacted directly providing them with an opportunity to comment on the PSPO, these were Bedfordshire Police, Bedfordshire Police and Crime Commissioners Office, Bedford Borough Parish Councils, BPHA, The Dog Trust and Orbit Housing.
- 8.5 The consultation asked the following two questions and received 130 responses see below:



8.6 In summary:

- 79% of responders either strongly agreed or agreed with extending the PSPO for dog control for a further three years, and
- 77% of responders either strongly agreed or agreed with adding the additional areas to the PSPO.





















Shortstown - Conder Boulevard Play Area














ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT 2014

SECTION 59 PUBLIC SPACES PROTECTION ORDER

THE BEDFORD BOROUGH COUNCIL

EXTENSION OF THE DOG CONTROL PUBLIC SPACES PROTECTION ORDER 2016 AS VARIED

The Bedford Borough Council Dog Control Public Spaces Protection Order 2016 ("the 2016 Order") was made by the Bedford Borough Council ("the Council") on 27th July 2016 and was varied as follows:

- 1. from 22nd November 2017 to add restricted areas; and
- 2. from 20th April 2018 to remove any discount for early payment of a fixed penalty notice.
- 3. from 27th July 2019 to extend the term of the order to 26th July 2022.
- 4. from 27th July 2022 to add restricted areas and extend the term of the order to 26th July 2025

The 2016 Order, as varied, is hereby further varied by

- (a) adding further areas detailed in part 3 of Schedule 1 and part 3 of Schedule 2 which are subject to the restrictions detailed below; and
- (b) extending the term of the 2016 Order, as varied from 27th July 2025 to 26th July 2028; and
- (c) removing the amount of the fixed Penalty Notice as £75

in each case because the Council is satisfied on reasonable grounds that activities of the nature specified in the restrictions below have been carried out, or are likely to be carried out in a public place in the administrative area of the Council and:

- Are having a detrimental effect on the quality of life of those in the locality, or
- It is likely that those activities will be carried out in a public place within that area that will have such an effect
- The effect or likely effect of those activities is or will be persistent or continuing in nature, and
- Are such as to justify the restrictions to be imposed.

THE DOG CONTROL AREAS

The 2016 Order came into force from 27th July 2016 and, as varied, applies the restrictions listed below to:

- (i) all land in a public place within the administrative area of the Council as specified below in respect of restrictions a)iii and a)iv; and
- (ii) those sites detailed in parts 1, 2 and 3 of Schedule 1 in respect of restriction a) i; and
- (iii) those sites detailed in parts 1, 2 and 3 of Schedule 2 of this Order in respect of restriction a) ii

a) RESTRICTIONS

i. Dogs Exclusion: (applies to those sites listed in Schedule 1)

A person in charge of a dog shall be guilty of an offence if, at any time, he takes the dog onto, or permits the dog to enter or to remain on, any land detailed in Schedule 1 below.

ii. Dogs on Leads: (applies to those sites listed in Schedule 2)

A person in charge of a dog shall be guilty of an offence if, at any time, (during the period specified in the schedule if stated), on land detailed in Schedule 2 below he does not keep the dog on a lead.

iii. Dogs on Leads by Direction: (applies to any part of the administrative area of the Borough)

A person in charge of a dog shall be guilty of an offence if, at any time, on land in a public place within the administrative area of the Council he does not comply with a direction given to him by an authorised officer to put and keep the dog on a lead, for such duration and in such manner as specified by the authorised officer.

iv. Fouling of Land by Dogs: (applies to any part of the administrative area of the Borough)

If a dog defecates at any time on land in a public place within the administrative area of the Council and a person who is in charge of the dog at the time fails to remove the faeces from the land forthwith, that person shall be guilty of an offence unless

- a) he has reasonable excuse for failing to do so;
- b) the owner, occupier or other person or authority having control of the land has consented (generally or specifically) to his failing to do so.

Nothing in the restrictions set out at (i), (ii) (iii) and (iv) above shall apply to a person who:

a) Is registered as a blind person in a register compiled under section 29 of the National Assistance Act 1948, where the offence is in relation to a dog upon which that person relies and which has been trained by a prescribed charity for assistance.

or:

b) A person with a disability affecting their mobility, manual dexterity or ability to lift, carry or move everyday objects in relation to a dog upon which that person relies and which has been trained by a prescribed charity for assistance.

For the purpose of this Order -

- "Public place" means any place to which the public or any section of the public has access, on payment or otherwise, as of right or by virtue of express or implied permission
- A person who habitually has a dog in his possession shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog;
- Placing the faeces in a receptacle on the land which is provided for the purpose, or for the disposal of waste, shall be sufficient removal from the land;
- Being unaware of the defecation (whether by reason of not being in the vicinity or otherwise), or not having a device for or other suitable means of removing the faeces shall not be a reasonable excuse for failing to remove the faeces
- "Authorised officer" means an employee, partnership agency or contractor of the Council who is authorised in writing by the Council for the purposes of giving directions under the Order.
- Each of the following is a "prescribed charity" -

Dogs for the Disabled (registered charily number 700454)

Support Dogs Limited (registered charity number 1088281)

Canine Partners for Independence (registered charity number (803680)

b) PERIOD FOR WHICH THE ORDER HAS EFFECT

The 2016 Order, as varied, is extended from 27th July 2025 to 26th July 2028.

At any point before the expiry of the aforementioned extended period the Council can review and vary the terms of the Order. As well as varying the Order the Council can also seek to discharge it at any time, subject to there being reasonable grounds to support such a decision.

c) WHAT HAPPENS IF YOU FAIL TO COMPLY WITH THIS ORDER?

Section 67 Anti-Social Behaviour, Crime and Policing Act 2014 states:

- 1) It is an offence for a person without reasonable excuse:
 - a) To do anything that the person is prohibited from doing by a public spaces protection order, or
 - b) To fail to comply with a requirement to which a person is subject under a public spaces protection order.
- 2) A person guilty of an offence under this section is liable on summary conviction to a fine not exceeding level 3 on the standard scale.
- 3) A person does not commit an offence under this section by failing to comply with a prohibition or requirement that the local authority did not have power to include in the public spaces protection order.

FIXED PENALTY

An authorised officer of the Council may issue a fixed penalty notice as an alternative to prosecution to anyone in contravention of the order. If you do not pay the fixed penalty notice you may be prosecuted.

APPEALS

D-4-----

Any challenge to this Order must be made in the High Court by an interested person within six weeks of it being made. An interested person is someone who lives in, regularly works in, or visits the restricted area. This means that only those who are directly affected by the restrictions have the power to challenge. The right to challenge also exists where an order is varied by the Council.

Interested persons can challenge the validity of this Order on two grounds, (i) that the Council does not have the power to make the Order or to include particular prohibitions or requirements; or (ii) that one of the requirements of the legislation has not been complied with.

When an application is made the High Court can decide to suspend the operation of the Order pending the Court's decision, in part or in totality. The High Court has the ability to uphold the Order, quash it, or vary it.
